- (3) Personal data are processed on the basis of voluntary consent and will not be made available to other recipients.
- (4) Provision of personal data by the student is a condition for participation in the procedure for granting a place in the Student Hostel of the Karkonosze University of Applied Sciences in Jelenia Góra.
- (5) Personal data shall be processed for the purpose of the procedure of assigning a place in the Student's House and for the entire period of residence on the basis of the Order No. 91/2021 of the Rector of the Karkonosze University of Applied Sciences in Jelenia Góra
- of 8 October 2021 on the introduction of the Regulations of the Resident of the Student's House for students of the Karkonosze University of Applied Sciences in Jelenia Góra in Jelenia Góra.

(6) Personal data will be stored until the end of the procedure of assigning a place in the Student's House and, within one month from the date of the decision not to assign a place, will be returned to the data owner at his/her request or destroyed. If a place is granted in the Student's House, personal data is processed for the entire period of residence. After the end of the period of residence, personal data is processed for 5 years for archival purposes pursuant to Regulation No. 35/2009 of the Rector of the Karkonosze University of Applied Sciences

in Jelenia Góra of 10 September 2009 on the introduction of the Office Instruction of the Karkonosze University of Applied Sciences in Jelenia Góra, the Uniform Nominative List of Records and the Instructions for the Organisation and Operation of the Archives of the Karkonosze State University of Higher Education in Jelenia Góra. 7.

In order to ensure the safety of the residents and protection of the property of the Student's House, pursuant to Article 22<sup>2</sup> of the Act of 26 June 1974. Labour Code, supervision of the area of the Student Residence is introduced in the form of technical means enabling image registration (monitoring). The monitoring covers the corridors on the residential levels, the basement corridor, the kitchen and club rooms and the area around the Student House. The surveillance cameras only record images that can be searched by time and place criteria

- (8) The image recordings shall only be processed for the purpose for which they were collected and shall be stored for up to 10 days, after which time they shall be permanently deleted.
- (9) In the event that the image recordings constitute evidence in proceedings under the law or the Director/Manager of the Student Residence has become aware that they may constitute evidence in the proceedings, the period specified in para. 8 shall be extended until the legal conclusion of the proceedings.
- (10) Personal data will be processed by University employees or by persons employed by KANS on the basis of civil law contracts on the basis of authorisations to process personal data granted by the Personal Data Administrator.
- (11) The Resident of the Student Residence has the right to request from the Personal Data Administrator access to their personal data, their rectification, deletion or restriction of processing within the limits allowed by law. He/she also has the right to receive in a structured, commonly used machine-readable format the personal data concerning him/her that he/she has provided to the Administrator.
- (12) There is no automated decision-making, including profiling, in relation to the personal data of residents of the Student House.
